A Classificatory Statistical Study of Mosul University Translation Department MA and PhD Theses (1986-2019) with Reference to Holmes's Map of Translation Studies

Abstract:

The present study aims to classify MA and PhD theses in translation, submitted to the Department of Translation¹ from 1986 to 2019, with reference to Holmes's Map of Translation Studies (1972). The problem that the study tries to address is that the main focus of research efforts exerted in the translation studies conducted at Mosul University have general tendency towards pure theoretical translation studies. It is hypothesized that applied translation studies have not been paid similar attention on the part of translation researchers. Through providing statistical data that highlight the areas of translation studies, which have not been covered through the period mentioned above, the researcher has found that a big gap exists, as far as the applied branch of translation studies is concerned. Consequently, the study encourages and recommends researchers in translation, at the MA and PhD levels, to submit their translation studies within the applied branch in order to fill the aforementioned gap. Applying new strategies, by the Department of Translation, for approving the research topics of MA and PhD theses in the master and doctoral programs is also recommended.

دراسة تصنيفية إحصائية لرسائل الماجستير وأطاريح الدكتوراه لقسم الترجمة في جامعة الموصل للمدة (1986 – 2019) حسب خارطة هولمز لدراسات الترجمة

ملخص البحث:

تهدف الدراسة الحالية الى تصنيف رسائل الماجستير وأطاريح الدكتوراه في الترجمة والتي تم تقديمها الى قسم الترجمة للمدة (1986 – 2019) اعتماداً على خارطة هولمز لدراسات الترجمة لعام (1972) . تحاول الدراسة التصدي لإشكالية كون التركيز الأساسي للجهود البحثية المبذولة في دراسات الترجمة التي أجريت في جامعة الموصل كان ينصب في ميله عموماً نحو دراسات الترجمة النظرية المحضة . تفترض الدراسة بأن دراسات الترجمة التطبيقية لم تتل اهتماماً مماثلاً من قِبل الباحثين في مجال الترجمة . ومن خلال توفير بيانات إحصائية تسلط الضوء على مجالات دراسات الترجمة التي لم يتم تغطيتها خلال المدة الزمنية المذكورة آنفاً ، اكتشف الباحث وجود فجوة كبيرة على قدر تعلق الأمر بالفرع التطبيقي لدراسات الترجمة . وبالتالي توصي الدراسة الباحثين في تخصص الترجمة في مستويات الماجستير والدكتوراه وتشجعهم على تقديم دراساتهم ضمن هذا الفرع لملء الفجوة آنفة الذكر . كما توصي الدراسة أيضاً بتطبيق قسم الترجمة لاستراتيجيات جديدة للموافقة على المواضيع البحثية لرسائل الماجستير وأطاريح الدكتوراه .

1. Holmes's Map of Translation Studies

Drawing attention to the fact that translation research is dispersed across older disciplines of languages, linguistics, etc., Holmes introduces his new ideas in a seminal paper submitted in 1972 entitled "*The Name and Nature of Translation Studies*" to the translation section of the 3rd International Congress of Applied Linguistics held in Copenhagen. In his paper he stresses the need to investigate other non-traditional disciplines in order to reach all scholars working in the field of translation from various backgrounds (Munday 2012, 16). He crucially puts forward an overall framework, describing what the discipline of translation studies covers. The following figure shows a tree diagram of his Map of Translation Studies:

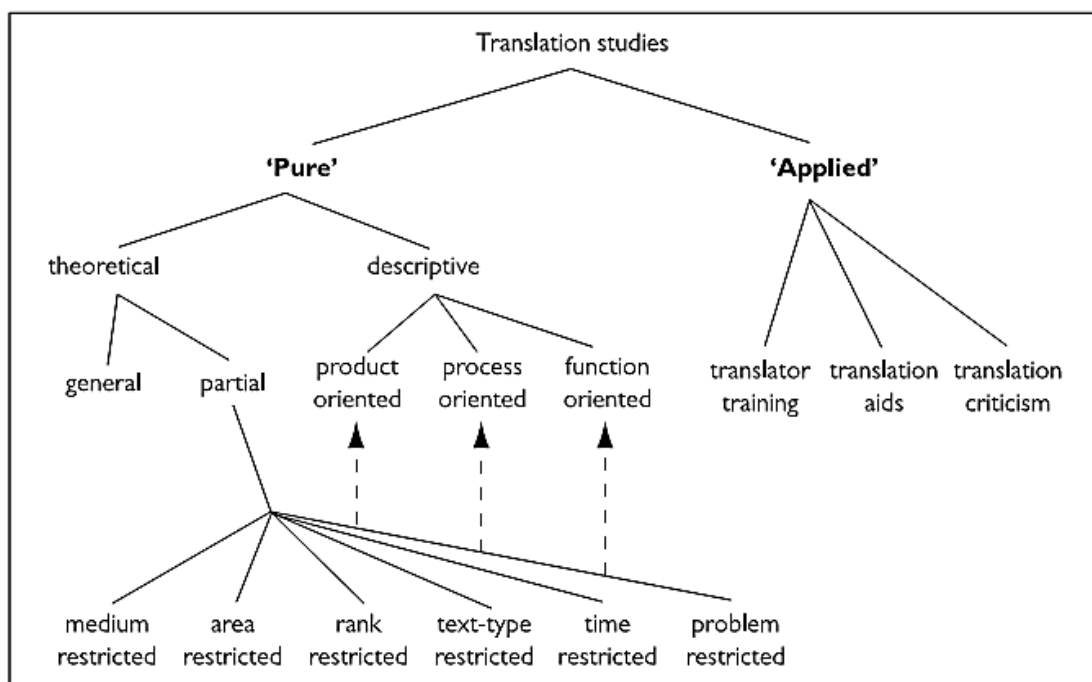


Figure 1– Holmes's Map of Translation Studies (cited in Munday, 2013:10)

In this tree diagram we can notice that the discipline of translation studies is divided into two main branches 'Pure' and 'Applied', which are in turn subdivided into

many other sub-branches. The following is a detailed account of these branches according to Munday (2013:16-18):

i. Pure: this branch aims to describe the phenomenon of translation and establish general principles to explain it.

a. Theoretical: this sub-branch is divided into **general** and **partial** theories.

- **General:** refers to the writings that pursue to describe every type of translation, making relevant generalizations for translation as a whole.
- **Partial:** restricting theoretical studies in accordance with the parameters discussed below:
 - **Medium-restricted Theories:** these are subdivided according to translation by humans or machines, to whether the human translation is written or spoken and to whether spoken translation (interpreting) is consecutive or simultaneous.
 - **Area-restricted Theories:** these are restricted to precise languages or sets of languages and/or cultures. This is closely related to the studies carried out in contrastive linguistics and stylistics.
 - **Rank-restricted Theories:** these are restricted to a specific level, normally word or sentence.
 - **Text-type Restricted Theories:** these are related to the types and genres of discourse, such as literary and technical translation.
 - **Time-restricted Theories:** these refer to theories and translations which are limited according to particular time frames and periods, such as the studies that tackle the history of translation.
 - **Problem-restricted Theories:** these refer to certain problems such as universality and equivalence.

b. Descriptive: this sub-branch may study translation being a product, a function, and a process.

- **Product Oriented:** studies the existing translations, which involves describing or analyzing a single ST-TT pair.



- **Function Oriented:** describes the translations in the target sociocultural context. This may include issues such as which texts were translated when and where, and the impacts that were exercised on their translation. According to Holmes, this area is termed "socio-translation studies".
 - **Process Oriented:** tackles the psychology of translation, i.e. what happens in the translator's mind. This includes think-aloud protocols from a cognitive perspective.
- ii. **Applied:** this branch is concerned with the practice of translation, it includes the following:
- **Translator Training:** such as translation pedagogy, testing techniques, and syllabus design.
 - **Translation Aids:** such as grammars and dictionaries.
 - **Translation Criticism:** such as translation evaluation, this includes marking student translations and reviewing published translations.

Commenting on the pure theoretical partial branch of Holmes's Map, Munday (2013:18) states that Holmes himself tries very hard to show that a number of different restrictions can apply at one time. For example, the study of the prefaces to the new English translations of novels by Marcel Proust would be area-restricted (translation from Parisian French into English), text-type restricted (prefaces to a novel), and time-restricted (1981-2003).

Moreover, Munday (ibid: 19) states that there are drawbacks to the structure of Holmes's Map as the divisions are in many ways artificial. He says that Holmes himself argues that there are influences among the theoretical, descriptive, and applied areas towards one another. This is found evident as our classification of the MA and PhD theses in the present study shows. Many of these theses share more than one division of Holmes's categorization. However, if one looks at this case as an overlap among various disciplines, one has to bear in mind that such an overlap is inevitable and cannot be avoided.

2. Analysis, Classification and Statistics

For more convenience and in order to carry out the analysis, the aforementioned branches and sub-branches are abbreviated as follows:

As mentioned earlier, according to Holmes himself the theoretical, descriptive, and applied areas do influence one another. We argue that this influence causes an overlap in Holmes's categorization, giving no clear-cut category for each of the theses mentioned in the table.

However, in the following lines, explanations for ascribing certain categories to certain theses for some entries in the table will be provided:

- No. (1): the MA thesis entitled '*Some Cultural Problems in English-Arabic Translation*' comes under PTPA, since it is restricted to specific languages, English and Arabic. It comes under PTPM, since it is restricted to written translation. It also comes under PTPPR, since it is addressing some cultural problems in English-Arabic translation.
- No. (3): the MA thesis entitled '*A Linguistic Study of Journalistic Translation from Arabic into English*', besides being under PTPA and PTPM, comes under PTP-txt, since it is restricted to the translation of Journalistic texts.
- No. (8): the MA thesis entitled '*Colour Terms in Modern English and Arabic Prose*', besides being under PTPA and PTPM, comes under PTPR, since it is restricted to the translation of a specific level, which is here the level of word, represented by colour terms.
- No. (11): the PhD thesis entitled '*A Study of Three Speech Acts: Promises Threats and Warning in There Shakespearean Tragedies with Reference to their Realization in*

Arabic', besides being under PTPA, PTP-txt, and PTPM, comes under PDFO, since it studies the functions of three English speech acts translated into recipient sociocultural situation in an Arabic context.

- No. (33): the PhD thesis entitled 'A Cognitive Pragmatic Approach to Translation', besides being under PTPA and PTPM, comes under PDPrO, since it is concerned with trying to find out what happens in the mind of the translator, through working from a cognitive perspective including the use of think-aloud protocols.
- No. (87): the PhD thesis entitled 'A Critical Study of Two Translations of the Book 'The Football International Laws' from English into Arabic', besides being under PTPA and PTPM, comes under ATC, since it is concerned with the evaluation of two translations of the book 'The Football International Laws'.
- No. (126): the MA thesis entitled 'Students Conception of Teaching Translation', besides being under PTPA and PTPM, comes under ATT, since it is concerned with teaching methods.

We can note that all MA and PhD theses mentioned in the table can be put under PTPA, since they are all restricted to specific languages, English and Arabic. It can also be noted that all MA and PhD theses mentioned in the table can be put under PTPM, and then distinguished according to the medium used, i.e. whether the translation research is done by machine or humans, whether the human translation is written or spoken, and whether spoken translation (interpreting) is consecutive or simultaneous.

As evident in the table, the following categories have not been tackled at all by all the MA and PhD theses:

a. PTG.

b. PTP-time.

c. PDPO.

d. ATA.

The following table shows how many times each category of translation studies has been tackled in the MA and PhD theses for the period (1986 – 2019):

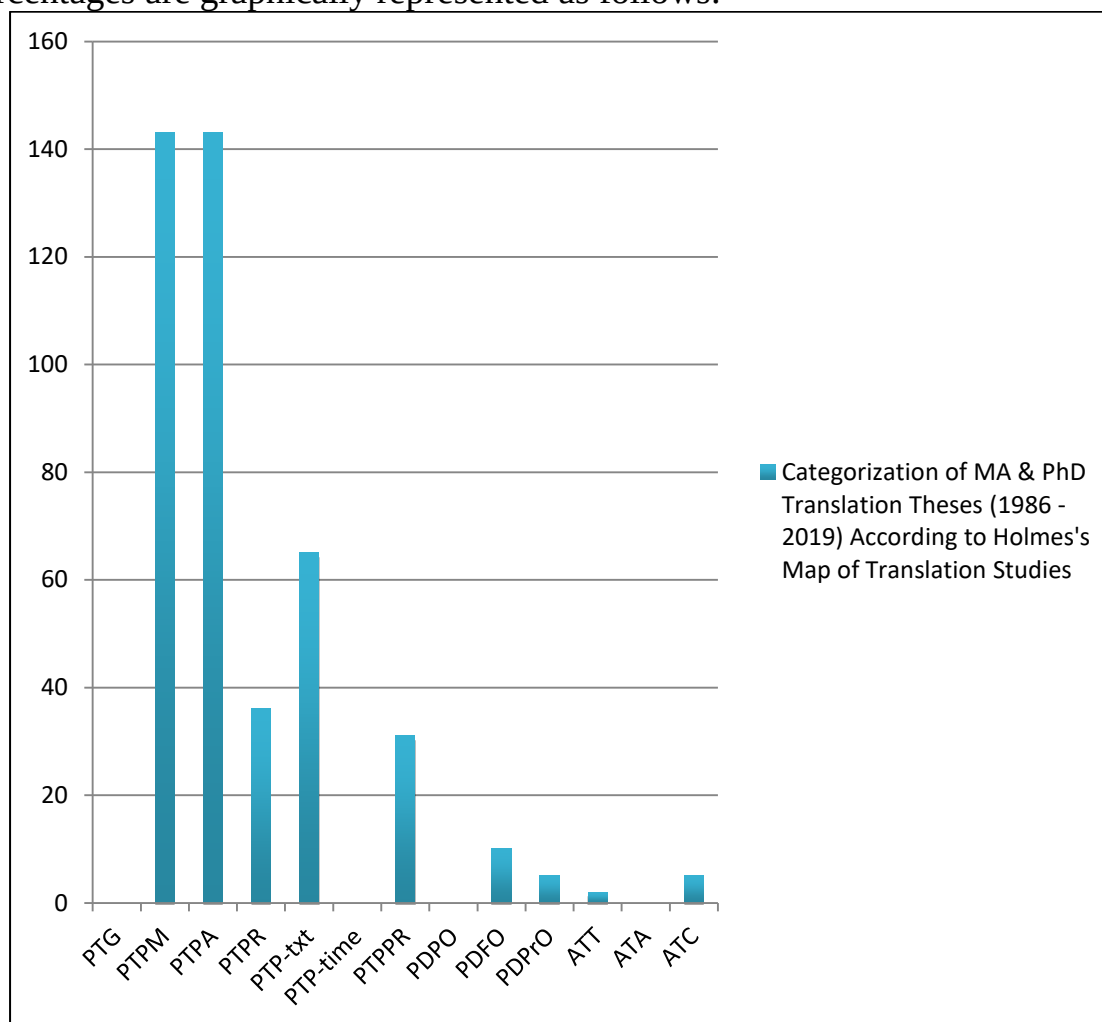


Figure 2 – Percentages of Categories of Translation Studies

3. Findings, Conclusions and Recommendations:



Having classified MA and PhD theses, submitted to the Department of Translation from 1986 to 2019, according to Holmes's Map of Translation Studies, it is found that the majority of research efforts were dedicated to PTPM and PTPA followed by PTP-txt, PTPR and PTPPR respectively. This group comes under the pure theoretical branch, a matter that supports our hypothesis. We believe that the selection of research topics was rather random and subject to personal interests by the researchers themselves in one area or another, away from any systematic discipline imposed by the Department of Translation.

As for PDFO, PDPrO and PDPO, despite being under the pure branch yet they have recorded low percentages. As far as PDPro, for example, is concerned, this can be due to the lack of having modern technological tools at the Department of Translation in Mosul University, in particular those dealing with the scanning and tracing of mental and cognitive activities that take place inside the mind of the translator. As for PTG, no study is conducted seeking to make a description of every type of translation for the sake of making generalizations for translation as a whole, all studies deal separately with specific types of translation. The same case is true for PTP-time, under which no study is recorded. This suggests that topics related to the history of translation are not favored as study areas by the Department of Translation or by the researchers themselves!

As for the group of ATA, ATT and ATC, low percentages are recorded, which again supports the hypothesis of the study. The reason behind this can be mainly due to the fact that the Translation Department was established as an independent department in 1986, which means that the discipline of translation, from an applied perspective, is still a young one in Mosul University. Through about 35 years, until 2019, we only have 7 theses under the applied branch of translation studies.

Another important point to be raised is that there were only (22) PhD theses discussed compared to (121) MA theses over about 35 years. This shows a great shortage in the number of PhD holders in the field of translation, those who graduated from the Department of Translation / University of Mosul since 1986. This is mainly due to the shortage in the number of professor doctors or assistant professor ones within the faculty members of the Department of Translation.

The present study recommends the Department of Translation to apply new strategies for approving the topics of MA and PhD theses in the master and



doctoral programs in a way that encourages researchers to delve in the investigation of research topics that have not been covered in the past 30 years.
